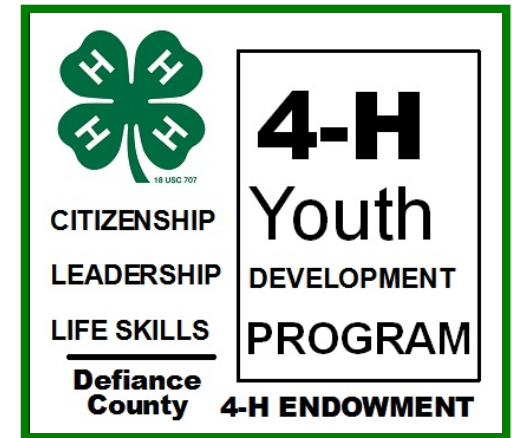

4-H Community Fund

This Fund was established in June, 2016 through the Defiance Area Foundation.

Distributions from this Fund is under the guidance of the Defiance County 4-H Endowment Committee. This is a "Donor Advised Fund" where the net income or principal or both may be allocated.

Grants may include but are not limited to: 4-H Award trips, 4-H Camper Scholarships, Academic Scholarships, Youth and Volunteer Recognition, Educational Supplies & Program Support and Teen & Adult Leader Training.



4-H Alumni Fund

This Fund was established 2012 through the Defiance Area Foundation.

Distributions from the Defiance County 4-H Alumni Fund is under the guidance of the Defiance County 4-H Advisory Council. This is a "Restricted Fund" where the 4-H program receives an annual grant award, which is the net income generated by the fund. The "principal" amount may not be allocated.

Grants may include but are not limited to: 4-H Member Retention, Financial assistance with 4-H projects, 4-H Camper Scholarships, and Agricultural Academic Scholarship.



4-H Endowment Fund

This Fund was established 1987 through The Ohio State University.

County 4-H endowments are permanent funds made possible through individual donations, business and corporate contributions and fund raising events. Principal is invested permanently through the Ohio State University to generate the maximum interest possible. The interest income returns to the county to fund local 4-H youth development education programs.

Gifts to the Defiance County 4-H Endowment Fund are recognized as a gift to The Ohio State University. Contributions are sent to the State 4-H Office earmarked for the Defiance County 4-H Endowment Fund and deposited with the Ohio 4-H Foundation which is a part of the University's development fund.

Levels of Giving

Bronze:	\$100 - \$499
Silver:	\$500 - \$999
Gold:	\$1000 - \$4999
Emerald:	\$5,000 & up
